After detailed deliberation, it was decided that mandatory provision of lift for the physical handicapped persons be made. The AGM of M/S NBCC Limited was asked to prepare a detailed drawings along with the detailed estimate and submit to the Principal, BCET, Gurdaspur who in turn will send to the XEN PWD, B&R, Pathankot and Shri Sarabjit Singh Bahga, Architect for perusal. After checking by them, these will be discussed with the Principal in detail before putting up in the next meeting of Buildings & Works Committee. This complete exercise will be completed in two months i.e. M/S NBCC Limited will provide the complete details within a period of one month and further discussed by XEN, PWD B & R, and Architect, Department of Architect, Punjab in a period of 15 days and further to be discussed in the joint meeting along with the Principal BCET, Gurdaspur in the next period of 15 days.

As per the decision taken in the meeting, M/S NBCC Limited submitted the drawings and specifications vide letter # DPM/CHD/GSR/2006/899 dated 12.5.2006 and the Chief Architect, Punjab was requested to give his comments. Then the Chief Architect, vide memo # C.A.2006/2237 dated 12.6.2006 informed that the design of the auditorium has been checked and he suggested the following two minor modifications:

- 1. Stage and back-stage area should be made accessible to physically challenged persons by providing ramp.
- 2. The main entrance porch seems to be too small (both in width and height) as compared to the volume of the building. Possibility may thus be explored to make it more spacious and grand so as to provide a befitting entry to the Auditorium.

Then M/S NBCC Limited was asked to carry out the modifications as per the comments of the Architect on 28.6.2006. M/S NBCC Limited vide # DPM/CHD/2006/1831 dated 13.10.2006 submitted a detailed estimate and one set of drawings for executing the construction work of Auditorium. The detailed estimate and set of drawings was sent to the Executive Engineer, PWD B&R, Pathankot vide # BCET/6422 dated 28th November 2006 to check the same. The Executive Engineer, PWD B&R, Pathankot vide # 12 dated 08.1.2007 submitted the detailed estimate after checking. The copies of the correspondence made are placed at ANNEXURE II from page 15 to 28. The various components of the estimates submitted by M/S NBCC Limited are as under and the amount includes 3% contingencies charges which have also been taken by PWD B&R while checking the estimates:

The estimate at Sr. # 2, 3 & 4 could not be checked by Executive Engineer, PWD (B&R). The item for approval is being taken up vide agenda item # 12.5.

A provision of Rs.60.00 lacs was made in the annual budget for the year 2007-2008 for construction of four multimedia lecture halls and the same has been approved in the 18th meeting of Finance Committee held on 02.5.2007. M/S NBCC Limited was asked to prepare an estimate for construction of additional class rooms and they have submitted the same vide # PM/NBCC/CHD/2007/419 dated 10.5.2007 amounting to Rs.53.26 lacs with the validity of the offer for 60 days only. A copy of the estimate and drawings is placed at ANNEXURE – IV from page 34 to 45.

Item # 12.4 TO APPROVE THE RE-CARPETING OF EXISTING ROADS AND CONSTRUCTION OF NEW ROADS WITHIN THE COLLEGE PREMISES.

The existing roads were constructed in the year 1995-1996 and the condition of these roads has been deteriorated. Further, with the development of the campus, the new roads with a length of about 300 feet at one place is also to be constructed. M/S NBCC Limited was requested to submit a detailed estimate. M/S NBCC Limited vide # NBCC/JAT/ BCET/2007/803 dated 28.5.2007 has submitted a detailed estimate amounting to Rs.36,31 lacs for re-carpeting of existing roads and construction of new roads within the college premises. Copy of the detailed estimates is placed at ANNEXURE - V from page 46 to 51. The Executive Engineer, Provincial Division, PWD B&R, Gurdaspur was also requested to provide an estimate for "laying semi dense bituminous concrete 30mm thick" in the Beant College of Engineering and Technology, Gurdaspur. They have submitted the detailed estimate amounting to Rs.28.73 lacs vide letter # 1110 dated 19.6.2007 for the same. A copy of the same is placed at ANNEXURE - VI from page 52 to 72. A provision of Rs.50.00 lacs for campus development including re-carpeting of roads has been made in the annual budget for the year 2007-2008. It is proposed that work of re-carpeting of existing roads and construction of new roads be given to PWD B&R, Punjab.
