Item No.2.1 Confirmation of Minutes of the First Meeting of the Finance Committee

It was resolved to confirm the minutes of the First Meeting .It was pointed out that Action Taken Report should be included as a part of the agenda for future meetings.

Item No. 2.2 Budget Estimates for the year 1996-97

The budget estimates for the financial year 1996-97 as detailed in agenda item 2.2 were presented by the Principal to the Committe. A balanced budget with proposed expenditure of Rs.693 lacs and an anticipated income of Rs. 693 lacs was presented. The expenditure conisted of i) Non-recurring: Rs. 567.00 lacs and (ii) Recurring Rs. 126.00 lacs.

The components of non-recurring included payments for land, buildings and development, equipment, vehicle and other facilities. The components of recurring expenditure included Pay and Allowances, T.A. and L.T.C. Medical reimbursement and contingencies.

The Committee discussed in detail the proposed budget estimates for 1996-97 and resolved to approve the same.

Additional requirement of Rs. 228 lacs for partial completion of priority buildings and development works, purchase of essential equipment to meet AICTE and University requirements and to meet maximum recurring expenditure was also noted and it was resolved that the demand will be submitted to the government in October 1996.

While discussing the details of the budget, a few suggestions were made as follows:-

- 1. The engineering colleges could enhance the income by resorting to the following steps:-
- i) by constructing small shops on the campus and realisation of rent/contract money,
- ii) by promoting consultancy ,
- iii)by organising extra classes for weak students
 on payment,
- iv) by revision of fee structure .
- 2. A standard list of equipment required for setting up a health centre in engineering colleges should be drawn up by collecting information from PHC, SHC and CHC. Sh B B Bhasin was asked to collect the relevant information.
- 3. The purchase procedures as provided in college bye-laws should be examined by DTE/IT for improvements, if any.

4. The internal telephone network cabling should be taken up at this stage of college development so that EPABX facility could be provided.

The meeting ended with a vote of thanks to the chair.
