Item No. 30.5 Review of Budget approved of Polytechnic Wing (established under NABARD scheme at BCET Gurdaspur) for the year 2015-16 after six months.

It was also directed to explore the possibility of procuring and installing grid based Solar Power Panels without battery storage.
