Proceedings of the first meeting of Finance Committee of Sardar Beant Singh State University, Gurdaspur held at 11:00 AM on 03.12.2021 through ONLINE mode in the office of Vice Chancellor -cum- Chairman Finance Committee, Sardar Beant Singh State University, Gurdaspur.

At the outset, Member Secretary welcomed the Hon'ble Chairman and members of Finance Committee of the University. Thereafter, all the items were discussed in detail and the following decisions were taken:

Item No. 1.1 Constitution of Finance Committee and delegation of Financial Powers.

The Item was approved as proposed.

Item No. 1.2 Opening and operation of Bank Account in the Name of Sardar Beant Singh State University, Gurdaspur.

The item was ratified.

Item No.1.3 Fee Structure for existing and proposed new courses.

The item was approved and it was further decided that the Development Funds collected from the students should not be more than 15% of the Tuition Fee amount.

Item No. 1.4 Budget Estimates for the Financial Year 2021-2022.

Since Beant College of Engineering & Technology, Gurdaspur has already been upgraded as Sardar Beant Singh State University, Gurdaspur under the Act No.09/2021 by Government of Punjab w.e.f. 1st April 2021, it was decided to transfer all the assets and liabilities of Beant College of Engineering & Technology, Gurdaspur to Sardar Beant Singh State University, Gurdaspur formally in the meeting of Society of Beant College of Engineering & Technology, Gurdaspur. Thereafter, put up the budget items in the next meeting of Finance Committee.

Item No. 1.5 Adoption of Purchase Rules of Maharaja Ranjit Singh Punjab Technical University Bathinda.

It was decided to adopt the purchase rules of BCET Gurdaspur and also adopt Punjab Govt. Purchase Rules where BCET purchase rules are silent, till the regulations for MRSPTU Bathinda are notified by Government of Punjab. Thereafter the notified regulations of MRSPTU, Bathinda shall be adopted by SBSSU, Gurdaspur.

Item No. 1.6 Confirmation of the minutes of 35th meeting of Finance Committee of Beant College of Engineering & Technology, Gurdaspur held on 20.8.2018.

Since this item belongs to Beant College of Engineering & Technology, Gurdaspur, it was decided to put up this item in the meeting of Society of Beant College of Engineering & Technology, Gurdaspur.

Item No. 1.7 To report the action taken on the decisions of 35th meeting of Finance Committee of Beant College of Engineering & Technology, Gurdaspur.

Since this item belongs to Beant College of Engineering & Technology, Gurdaspur, it was decided to put up this item in the meeting of Society of Beant College of Engineering & Technology, Gurdaspur.

Item No.1.8 Release of pending salaries to the employees from December 2020 to March 2021 in compliance to the order of Hon'ble High Court in the case of Arpinder Singh & Others.

In view of the directions issued on 23.11.2021 by Hon'ble Punjab & Haryana High Court vide CWP No.9300-2021 and CWP No.10489-2021 – Sh. Arpinder Singh & Others, it was decided to release due pending salaries to all retired seven employees including petitioners from the available funds of BCET, Gurdaspur. Further, it was decided to put up this item for release of pending salaries to the remaining employees in the next meeting of Society of Beant College of Engineering & Technology, Gurdaspur.

Item No. 1.9.1 White Wash of Buildings of the University.


The item was approved and it was further decided to carry out this work through PWD (B&R), Punjab.


Meeting ended with a vote of thanks to the Chair.
